We, the undersigned subscribers to these Articles of Incorporation, do hereby form
corporation for profit under the laws of the State of Florida, as follows:

ARTICLE I: NAME

HOLTON and JAMI L. HOLTON of 5400 Southerly Way, Sarasota, FL 34232.



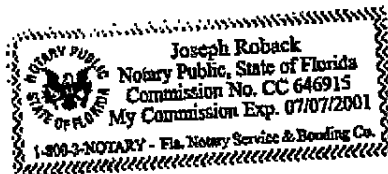
