The undersigned subscriber to these Articles of Incorporation, Susan B. Wiesing, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

#### ARTICLE I

# CORPORATE NAME

The name of this Corporation is WIESING ENTERPRISES, INC. The principal officer and mailing address of the corporation is 1111 Sixth Street South, Naples, Florida 341020

#### ARTICLE II

# **DURATION**

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

## ARTICLE III

#### **PURPOSE**
