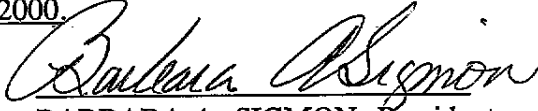
**ARTICLE XI.**

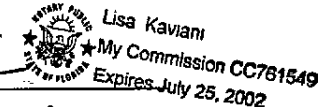

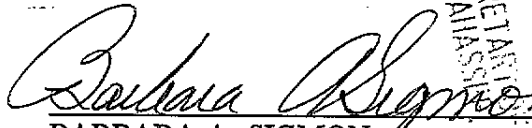

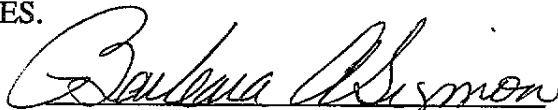
