## ARTICLES OF INCORPORATION OF HEALTHCARE TECHNOLOGY PARTNERS, INC.

I, the undersigned, hereby make, subscribe, acknowledge, and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

#### ARTICLE I

#### **IDENTIFICATION**

#### ADDITIONAL PROVISIONS

The following additional provisions for the regulation of the business and for the conduct of the affairs of the corporation, and creating, dividing, limiting, and regulating the powers of the corporation, its stockholders, and Directors are hereby adopted as a part of these Articles of Incorporation:

1. The Board of Directors from time to time shall determine whether and to what extent, and at what times and places, and under what conditions and regulations, the accounts and books of the corporation, or any of them, shall be opened to the inspection of the stockholders, and no stockholder shall have the right to inspect any account or document of the corporation except as conferred by a statute or authorized by the Board of Directors or by resolution of the stockholders.

- No person shall be required to own, hold, or control 2. stock in the corporation as a condition precedent to holding an office in this corporation.
- Except as otherwise provided by law, the Directors 3. may prescribe a method or methods for replacement of lost certificates, and may prescribe reasonable conditions by way of security upon the issuance of new certificates therefor.
- This corporation shall indemnify any officer or Director, and any former officer or Director, to the full extent provided law. This corporation may provide indemnification, or a portion thereof, through the purchase of insurance.
- The power to adopt, alter, and repeal By-laws shall 5. be in the Board of Directors of the corporation or in the stockholders; By-laws adopted by the Board of Directors may be altered or repealed by the stockholder and vice versa, except that the stockholders may prescribe in any By-law made by them that such By-law shall not be altered, amended, or repealed by the Board of Directors.
