## ARTICLES OF INCORPORATION OF NIOBI CLEANING, INC.

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I - Name

The name of the corporation is Niobi Cleaning, Inc. The principal place of business of the corporation is 907 W. 7<sup>th</sup> Street, Lehigh Acres, Fl. 33936. The mailing address of the corporation is 907 W. 7<sup>th</sup> Street, Lehigh Acres, Fl. 33936.

#### ARTICLE II - Commencement and Duration

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according the law.


