The Undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I - NAME


ARTICLE IX - AMENDMENT

ARTICLE X - CORPORATE EXISTENCE


The date of commencement of corporate existence shall be January 1, 2001.
