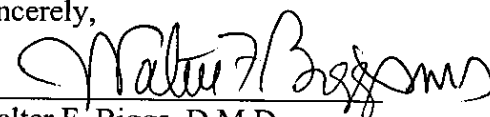
RE: Late Filing of 2002 Uniform Business Report
