

ARTICLES OF INCORPORATION  
OF

ARTICLE ONE-NAME

The name of the corporation is C. Dwight Baker, CPA, PA, whose principal office and mailing address is 80 Royal Palm Pointe, Suite 202, Vero Beach, Fl 32960-4227.

ARTICLE TWO-PURPOSE

This corporation is organized for the purpose of providing accounting, auditing, consulting and tax services as permitted by the State of Florida.

ARTICLE THREE-CAPITAL STOCK

This corporation is authorized to issue one thousand shares of one dollar par value common stock, which shall be designated "Common Shares".

ARTICLE FOUR-PREEMPTIVE RIGHTS



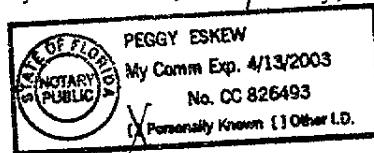
