## ARTICLE ONE

The name of this corporation is SILICON SWAMP TECHNOLOGIES, INC. and the mailing address of the corporation shall be 2222 Second Street, Fort Myers, FL 33901.

## **ARTICLE TWO**

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed.

#### **ARTICLE THREE**

The duration of the corporation is perpetual.
