The undersigned incorporator hereby executes, acknowledges and files with the Florida Department of State the following Articles of Incorporation (the "Articles") for the purpose of organizing a corporation under the Florida Business Corporation Act (the "Act").

ARTICLE I - Name of Corporation

The name of the corporation is R&R FOOD DISTRIBUTORS, INC.

ARTICLE II - Principal Office

The initial principal place of business or mailing address of the Corporation shall be 272 East 5th Street, Hialeah, FL 33010.

ARTICLE III - Term of Existence

This corporation shall exist perpetually.
