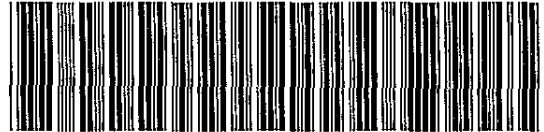

NAME

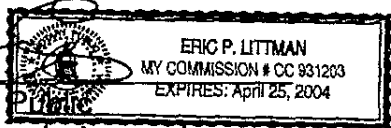
1. Effective May 16, 2003, the name of this corporation shall be Hillsboro Group, Inc.
