
ARTICLE IX – INDEMNIFICATION

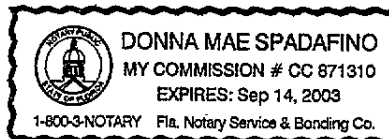
