

The number of directors may be raised or lowered by amendment of the bylaws of the corporation but shall in no case be less than one.


6. The incorporator of this corporation is Sean P. Jennings whose street address is 108 Robin Road Suite #1010, Altamonte Springs, Florida, 32701.
