The name of this corporation is

ARTICLE II. DURATION

This corporation shall commenced January 1, 2001, and shall have perpetual existence.

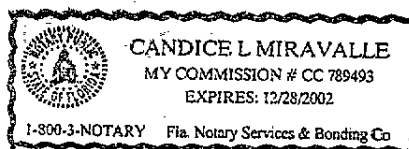


