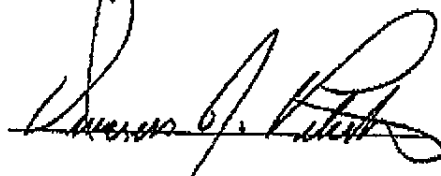
**ARTICLE X. AMENDMENT**
