The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I

NAME AND PRINCIPAL ADDRESS OF CORPORATION

The name of this corporation shall be BENNETT PROPERTIES REALTY, INC., and the principal address of the corporation is 4001 McLane Drive, Tampa, Florida, 33610.

ARTICLE II

COMMENCEMENT AND DURATION

The Corporation shall commence to exist as of January 1, 2001, and shall exist perpetually thereafter until dissolved.

ARTICLE III

PURPOSE
