**ARTICLE I: NAME**

The name of the corporation is: SDR Investments, Inc.

**ARTICLE II: NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is to do all things which natural persons might lawfully do in the premises as follows: Investment in real and personal property, related products and services, and other investments of every kind, nature, and description.

**ARTICLE III: CAPITAL STOCK**
