ARTICLES OF INCORPORATION
OF
JOGARTE, CORP.
a Florida Corporation

The undersigned, acting as Incorporator of a Florida corporation ("Corporation"), under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is JOGARTE, CORP.

ARTICLE II

OFFICE AND MAILING ADDRESS

The initial principal office of the Corporation is located at 351 Altara Avenue, Coral Gables, Florida 33146, and the mailing address of the Corporation is c/o Ivan A. Gomez, P.A., 601 Brickell Key Drive, Suite 507, Miami, Florida 33131.

ARTICLE III

DURATION

The Corporation shall have perpetual existence.

ARTICLE IV

PURPOSE

The Corporation is organized for the purpose of transacting

ARTICLE V

CAPITAL STOCK
