At a duly convened meeting of all shareholders of the corporation held on June 18, 2001, the following amendment to the Articles of Incorporation of RICHARD A. SELINGER, P.A. was adopted effective on July 1, 2001. The Articles of Incorporation shall remain the same in every other respect:

ARTICLE I  
Name and Principal Place of Business
