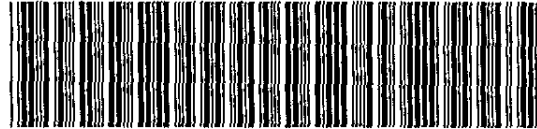

At a duly convened meeting of all shareholders of the corporation held on June 24, 2004, the following amendment to the Articles of Incorporation of SELINGER AND FLETCHER, P.A. was adopted effective on July 1, 2004. The Articles of Incorporation shall remain the same in every other respect:
