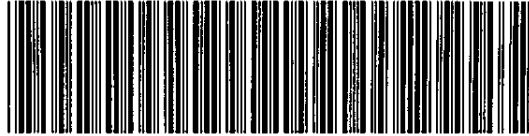

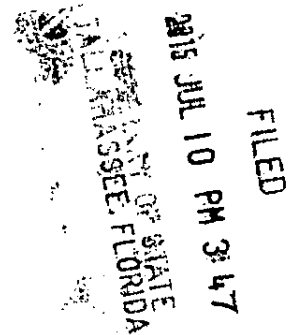



At a duly convened meeting of all shareholders of the corporation held on June 29, 2015, the following amendment to the Articles of Incorporation of SELINGER AND FLETCHER, P.A. was adopted effective on July 1, 2015. The Articles of Incorporation shall remain the same in every other respect:

**ARTICLE I
Name and Principal Place of Business**

Effective July 1, 2015, the name of the corporation shall be **SELINGER LAW FIRM, P.A.** The Principal office of the corporation shall be located at the Blackstone Building, 233 East Bay Street, Suite 1133, Jacksonville, Florida 32202.
