The undersigned incorporator, for the purpose of forming a corporation under Chapter 607 and/or Chapter 621, Florida Statutes, hereby adopts the following Articles of Incorporation.

(1) This corporation is authorized to issue only one class of stock; and the number of shares of stock that this corporation is authorized to have outstanding at any one time is 100.

(2) All of the corporation's stock, exclusive of treasury shares, shall be held of record by not more than seventy-five (75) persons.

(3) Each shareholder shall offer to the corporation or the other shareholders of the corporation a thirty(30) day "first refusal" option to purchase the stock of the shareholder electing to sell stock in the corporation.

(4) No shareholder may transfer stock to an ineligible shareholder (i.e. those ineligible to hold stock in an S corporation) without the consent of the other shareholders.
