OF

ARTICLE I NAME

EFFECTIVE DATE

The name of the corporation shall be J & B DOORS AND TRIM, INC. 01-01-01

ARTICLE II PURPOSE

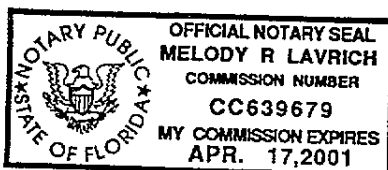

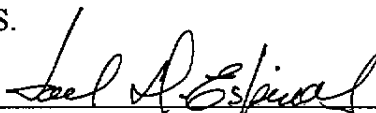
