The name of the corporation is: **LAUREL CROWN, CORP.**

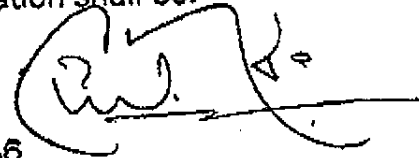
