To whom it may concern:

I spoke with someone in your offices on Tuesday, May 4, 2004 in reference to the above-described document. It was brought to my attention during conversation, that this form was due for renewal and that I had not submitted the form as of yet. It was suggested that I send an explanation as to why I had not filed yet, for consideration of waiving the increased fee, which would now be due. I am submitting the following for my reason:

My father was diagnosed with cancer some years ago, went thru extensive treatment, and then went into remission. In Spring of 2003, the cancer came back. He has been going thru treatment since that time. I am the person responsible for driving my father and mother to the hospital each and every week, sometimes four times a week, from Port Charlotte, FL to Tampa, FL, for the extensive treatments he must receive in order to survive. The roundtrip mileage is in excess of 200 miles for each trip, and each trip is a minimum of one entire day, sometimes a few in a row. This has put an emotional stain on myself, as I am sure you can imagine, thus my oversight for not submitting the Annual Report on time. My main focus has been on my father and his treatments and his eventual remission. This is not my excuse; it is my truth, for my failure to file my "2004 For Profit Corporation Annual Report".

I hope you will take this into consideration while I submit my Annual Report to you. I am enclosing the original fee of \$150.00. If you decide not to take my explanation into consideration, I will pay the additional fee required for the filing of Annual Report.

I will wait to hear from you on your decision, and want to thank you for your time and consideration in this matter.
