**ARTICLES OF INCORPORATION  
OF

The undersigned incorporator (s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt (s) the following Articles of Incorporation.

**ARTICLE I  
CORPORATE NAME**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.


### CERTIFICATE
