ARTICLES OF INCORPORATION of TRADEDIRECT USA, INC.

THE UNDERSIGNED, acting as the sole incorporator of TradeDirect USA, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation of TradeDirect USA, Inc. for such corporation:

ARTICLE I

Name and Address

The name of the corporation shall be **TradeDirect USA**, **Inc.**, and its principal corporate address shall be initially located at 2704 Rew Circle, Suite 105, Ocoee, Florida 34761.

<u>ARTICLE II</u>

Duration

This corporation shall have perpetual existence unless sooner dissolved according to law, and shall commence its corporate existence upon the filing of these Articles.

ARTICLE III

General Purposes

This corporation is organized for the purpose of transacting, conducting, carrying on, operating, and engaging in any activity or business permitted under the laws of the State of Florida, and the United States.

ARTICLE IV Shares

The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000), consisting of a single class of common stock, \$0.001 par value per share.
