**ARTICLES OF INCORPORATION**  
of

**THE UNDERSIGNED**, acting as the sole incorporator of TradeDirect USA, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation of TradeDirect USA, Inc. for such corporation:

**ARTICLE I**

**Name and Address**


