The undersigned, for the purpose of forming a corporation under Chapter 607, the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is CHET'S SEPTIC SERVICE, INC. and the corporate existence shall commence as of the date of the filing of these Articles of Incorporation.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized is to engage in the septic service business; and to purchase, lease, or otherwise acquire such grounds or buildings as this corporation may need in carrying on its business; and to transact any other lawful business or business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE FOUR

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 100 shares of "Class A" voting stock, having a par value of One Dollar (\$1.00) per share, and 300 shares of "Class B" non-voting stock, having a par value of One Dollar (\$1.00) per share.

ARTICLE FIVE

The street address of the initial registered office of the corporation is 1975 Piper Dr., Inverness, FL 34450, and the name of its initial registered agent is CHESTER PAUL DELLICH, JR., of 1711 N. Croft Ave., Inverness, FL 34450.

ARTICLE SIX

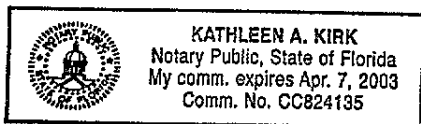

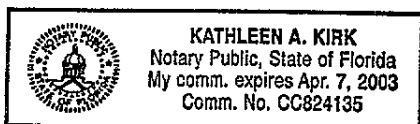

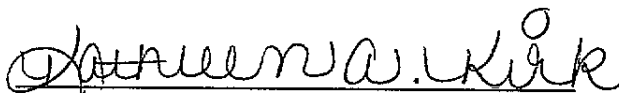
