ARTICLES OF INCORPORATION OF PIER & COMPANY

The undersigned acting as incorporator of a corporation under the Florica General Corporation Act, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE 1 - NAME

The name of the corporation is Pier & Company The mailing address of the corporation is 2000 L'Ambiance Circle #202, Naples, Florida 34108.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - COMMENCEMENT AND DURATION

The corporation is to commence its corporate existence on January 1, 2001, and shall exist perpetually thereafter until dissolved according to law.


