The undersigned acting as incorporator of a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE 1 - NAME

The name of the corporation is Pier & Company. The mailing address of the corporation is 2000 L' Ambiance Circle #202, Naples, Florida 34108.

ARTICLE II - PRINCIPAL OFFICE

The street address of the principal office of this corporation is 2000 L' Ambiance Circle #202, Naples, Florida 34108.

ARTICLE III - COMMENCEMENT AND DURATION

EFFECTIVE DATE
01-01-01

The corporation is to commence its corporate existence on January 1, 2001, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE IV - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock with a par value of \$1.00 per share.

ARTICLE VI - SPECIAL PROVISIONS

The corporation hereby makes the IRC 1244 election.

ARTICLE VII - PRE-EMPTIVE RIGHTS

Every shareholder, upon the issuance of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share at the price at which it is offered to others.

ARTICLE VIII - INITIAL REGISTERED OFFICE AND AGENT

The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

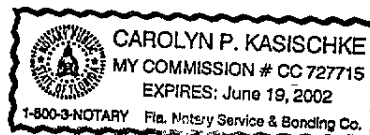
