

ARTICLE I - NAME

The name of this corporation is Jerome L. Rosen, C.P.A., P.A.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual and shall commence upon the signing and acknowledging of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business as a Certified Public Accountant.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of One-Dollar (\$1.00) par value common stock. All stock of the corporation shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1954 as added by the Small Business Tax Revision Act of 1958.

All of said stock shall be payable in cash, or property, other than stock or securities, in lieu of cash, or services, at a just valuation to be determined by the Board of Directors of this corporation.

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation 7880 N. University Drive, Suite 201, Tamarac, FL 33321, and the name of the initial registered agent of this corporation is Jerome L. Rosen.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have three (1) director initially. The number of directors may be increased or diminished from time to time by the by-laws, but shall never be less than one (1). The name and address of the person signing these Articles is Jerome L. Rosen.


ARTICLE X - INDEMNIFICATION
