The undersigned Incorporator of these Articles of Incorporation, is a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I. NAME

The name of this corporation is:

## ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to print, bind, publish, circulate, distribute, buy sell and deal in books, pamphlets, circulars, posters, newspapers, magazines, literature, music, pictures, tickets, and legal, commercial, and financial forms and blanks; to acquire by purchase or otherwise, turn to account, license the use of, assign and deal with copyrights and intellectual properties of every kind; and to carry on a general printing, engraving, lithographing, electrotyping and publishing business, using computer, visual arts of present and future technology to customers in the state of Florida and other states and countries, and to engage in every and any aspect and phase of any and every lawful business, including, but not limited to, the following activities:
