**ARTICLE I**

The name of the Corporation ("Corporation") is Sugar Shack Promotions, Inc.

**ARTICLE II**

The existence of the Corporation shall begin on that date which is five days after the filing date of these Articles of Incorporation.

**ARTICLE III**

The street address of the principal office of the Corporation is 1375 Jackson Street, Suite 406, Fort Myers, Florida, 33901. The mailing address of the Corporation is P.O. Box 2118, Fort Myers, Florida, 33902-2118.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 100 shares, par value \$0.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

**ARTICLE V**

The Corporation elects to have Preemptive rights for its shareholders.

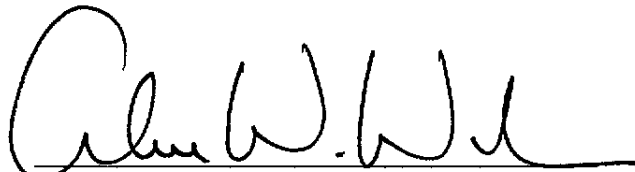

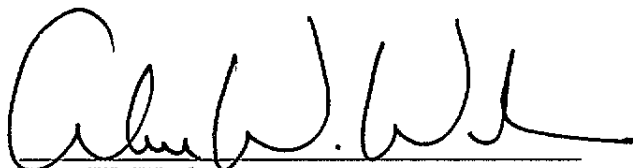
