

ARTICLES OF INCORPORATION OF SUGAR SHACK PROMOTIONS, INC.



ARTICLE I

The name of the Corporation ("Corporation") is Sugar Shack Promotions, Inc.

ARTICLE II

The existence of the Corporation shall begin on that date which is five days after the filing date of these Articles of Incorporation.

ARTICLE III

The Corporation elects to have Preemptive rights for its shareholders.
