ARTICLE I

The name of the corporation is Gayle's Pets Plus, Inc. The street address of the initial registered office of this corporation is 2500 South Hopkins Avenue, Titusville, FL 32780. The name of the initial registered agent of this corporation at that address is Gayle Barrett.

ARTICLE II - DURATION

The corporation shall exist perpetually, commencing at the time of filing these articles with the state of Florida.

ARTICLE III - PURPOSES

This corporation is organized for the purposes of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation shall have perpetual existence unless dissolved by law.

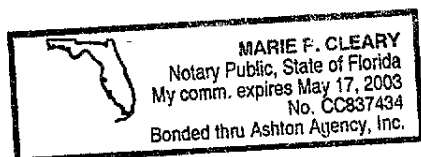
The private property of the officers, directors and stockholders shall not be subject to the payment of corporate debts to any extent whatsoever.

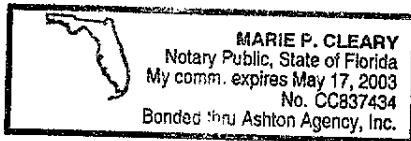
