ARTICLE ONE
NAME

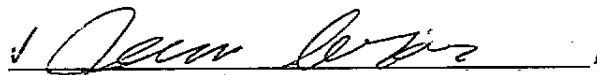

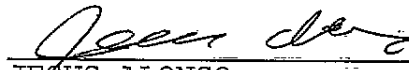
