ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be ERAL, INC.

ARTICLE II - CORPORATE ADDRESS

ARTICLE III - BEGINNING OF CORPORATE EXISTENCE

The existence of this corporation shall commence on the 2nd day of January, 2001;
provided that if such day be authorized under law, then on the earliest day allowable
pursuant to Florida law for commencement of corporate existence.

The existence of this corporation shall be perpetual.

ARTICLE IV - PURPOSE


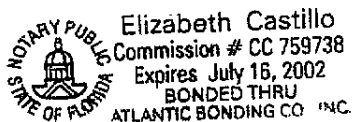
