CERTIFICATE OF INCORPORATION

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation

ARTICLE I: The name of the corporation is AIR Direct Support, Inc.

ARTICLE II: The mailing address of this corporation is 2757 Jefferson Street Marianna, FL 32448

ARTICLE III: The purpose for which the corporation is formed is to engage in any and all lawful business for which corporations may be organized under the business corporation law, providing that the corporation is not formed to engaged in any act or activity which requires the act or approval of any state official, department, or other body without such approval or consent first being obtained. The aggregate number of shares which the corporation shall have the authority to issue is Two Hundred, all of which shall be without par value.
