# ARTICLES OF INCORPORATION

<u>OF</u>

## STARBOUND EXPRESS ENTERPRISES, INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

#### **ARTICLE I**

The name of this corporation is STARBOUND EXPRESS ENTERPRISES, INC., with its principal office located at 1 Brookside Circle, Ormond Beach, Florida, 32174.

## ARTICLE II

This corporation shall have perpetual existence.

#### **ARTICLE III**

The general nature of the business to be transacted by this corporation is as follows:

- (a). To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
- (b). To own, operate and maintain and to acquire by purchase, lease, or otherwise track tractor trailers and lines or any other means of transportation of freight, mail, express baggage goods, wares, merchandise or other property of every kind and nature.
