ARTICLES OF INCORPORATION CENTRAL FLORIDA ADDICTION REHABILITATION, INC.

The undersigned for the purpose of forming a corporation for profit under the laws of Floradopts the following Articles of Incorporation:

Article I NAME

Section 1.1. Name. The name of the corporation is CENTRAL FLORIDA ADDICTION REHABILITATION, INC.

Article II DURATION

<u>Section 2.1. Duration.</u> This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of Florida within ten days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

Article III PURPOSES

Section 3.1. Purposes. This corporation is organized for the purpose of transacting any lawful act or activity for which corporations may be organized under the laws of the State of Florida. The general nature of the business to be transacted by this corporation is: to manufacture, transfer, sell, or otherwise dispose of, and to invest in, trade in, deal in, consult for, and with goods, wares merchandise, real and personal property and services of every kind, class and description.

Article IV CAPITAL STOCK

- <u>Section 4.1. Authorized Capital.</u> The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.
- <u>Section 4.2.</u> Restrictions on Transfer of Stock. Shareholders must first offer shares to the corporation or other existing shareholders prior to offering shares to other prospective purchasers.
- Section 4.3. Approval of Shareholders Required for Merger. The approval of a majority of the shareholders of this corporation to any plan of merger or consolidation shall be required in every case, whether or not such approval is required by law.
 - Section 4.4. Preemptive Rights. Shareholders shall have no preemptive rights.
 - Section 4.5. Cumulative Voting. Cumulative voting shall not be permitted.
