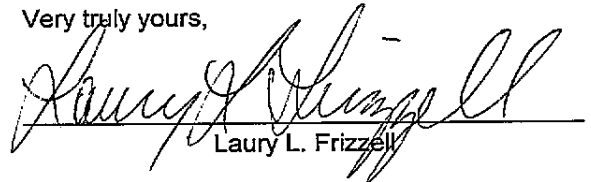

TO

ARTICLE II. ADDRESS

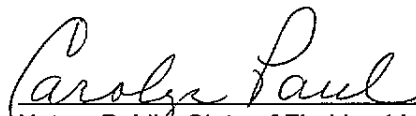

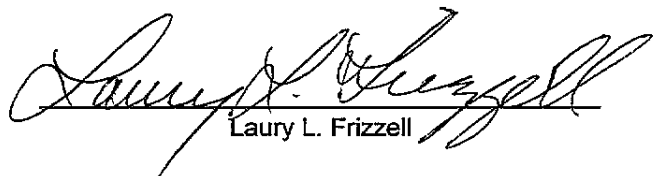
