ARTICLES OF INCORPORATION
OF
THE PEOPLE'S COMPANY, INC.

ARTICLE I—NAME

The name of this corporation is THE PEOPLE'S COMPANY, INC.

ARTICLE II—DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III—PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as a Security and Entertainment sales company, and performing any other lawful purpose in any industry the company so deems fit.

ARTICLE IV—CAPITAL STOCK

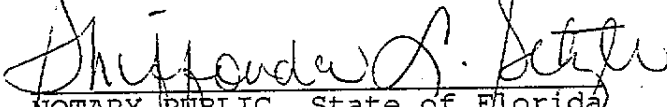

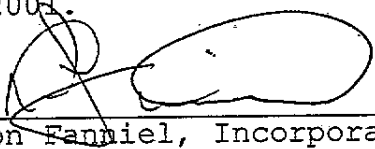

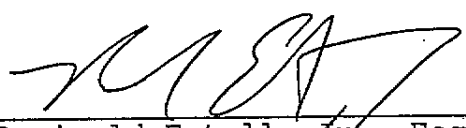
