The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be D & D Transcription Services, Inc.

This corporation shall exist perpetually.


ARTICLE IX - BYLAWS



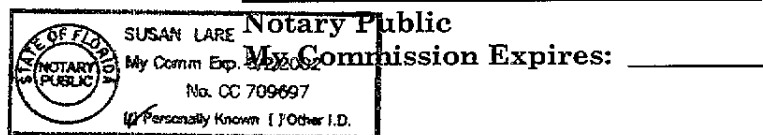
