ARTICLES OF INCORPORATION

**ARTICLE I
CORPORATE NAME**

The name of the Corporation is Rosemarie Brown Stained Glass Design, Inc.

**ARTICLE II
PURPOSE**

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Corporate Law of the State of Florida other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the State of Florida's Corporations Code.

The duration of the Corporation shall be perpetual.

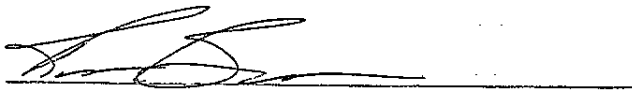

The number of directors constituting the initial Board of Directors of the Corporation is one.

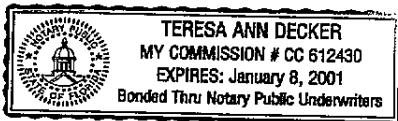

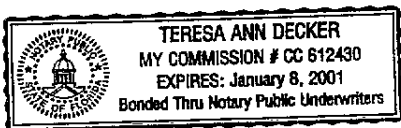
