# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF HILLSIDE/TARPON SPRINGS MOBILE HOME PARK, INC.

#### "ARTICLE I

### CORPORATE NAME AND PRINCIPAL OFFICE

The amendment recited in Section 1. above has been duly adopted in accordance with the provisions of \$607.0821, .0704, .1003 and .1006, Florida Statutes, the shareholders and directors of the Corporation having executed a written statement, dated March 27, 2006, manifesting their intention that the amendment be adopted.
