I, the undersigned, hereby make, subscribe, and file these Articles for the purpose of forming a corporation under the laws of the State of Florida:

## ARTICLE I

Name 1

The name of this corporation shall be CARIBAGRO CORP.

#### ARTICLE II

<u>Purpose</u>
