**ARTICLES OF INCORPORATION
OF
PLANTATION LAWN MAINTENANCE AND LANDSCAPING, INC.**

**The undersigned incorporator forms a corporation in accordance with
the Florida Business Corporations Act, and adopts the following Articles
of Incorporation for the corporation with an effective date of January 2, 2001:**

ARTICLE 1 - NAME/ADDRESS
