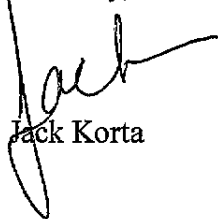

ARTICLE I - NAME

The name of this Corporation shall be:
Dolcater & Company, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 01/01/01

ARTICLE III - PURPOSE

ARTICLE IX - AMENDMENT

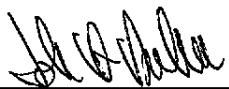
