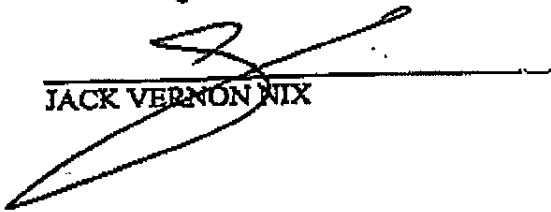
ARTICLE IX
